

Among the more heavily discussed topics was the budget for the state of Missouri. Representative Flanigan (vice-chair of the House budget committee) explained in detail how the budget is decided, and what factors influence deciding which programs get funding and how much funding they receive. This proved of great interest to the audience, especially considering the addition of \$200,000 from the state of Missouri for the Dental Van Program.

worked so hard so these youth people can live their dream.



## Webb City #861 Government Day



“Never doubt that a small group of thoughtful, committed citizens can change the world; indeed, it’s the only thing that ever has.”

Those words were once uttered by Margaret Mead, and on Saturday, January 25, 2014, we put into action at Webb City Elks #861. The Lodge hosted its second in a series of meetings with state and Federal elected officials, not only learning what issues were taking shape in Jefferson City and Washington, D.C., but also providing input about what matters they felt were most important.

Missouri State Senator Ron Richard, Missouri State Representatives Bill Lant, Bill White, Charlie Davis and Tom Flanigan were joined by Jake Heisten, field representative for US Congressman Billy Long and Steve McIntosh, field representative for US Senator Roy Blunt.

The meeting began with a presentation by past state president Marc Beckman about the Missouri Elks Association Dental Van, followed by a presentation by each of the guests about the work being done by our Federal and state governments.

Among the more heavily discussed topics was the budget for the state of Missouri. Representative Flanigan (vice-chair of the House budget committee) explained in detail how the budget is decided, and what factors influence deciding which programs get how much funding. This proved of great interest to the audience, especially considering the addition of \$200,000 from the state of Missouri for the Dental Van Program.

However, not all topics were directly related to the Elks. When asked about the possibility of Missouri following in the footsteps of states like Colorado and Washington and changing laws regarding marijuana, the panel gave a resounding “no” to that ever happening. Senator Richard went so far as to tell the audience such a measure would “have no chance of making it out of committee,” let alone going before the governor to get signed into law. Mr Heisten then reminded the audience that, while some states may have taken steps to change their own laws, Federal law was still supreme on the matter, and that such actions would eventually have consequences at the Federal level.

Despite the wide range of topics covered, it was a comment from one of the men on the panel that caused the greatest surprise in the room. During his time at the podium, Senator Richard spoke to audience about his familiarity with the organization:

“I was looking in my wallet the other day, and suddenly realized I have been an Elk for more than 40 years.”

The surprise in the room was palpable, as many did not perhaps expect that would have “friends in high places,” as the saying goes.

While the two and half hour meeting may seem short, it appeared from my vantage point to accomplish the goal it was begun with: to inspire conversation. Afterwards, when the official meeting had ended, many of the legislators stayed around to speak at length with the Elk present about topics already covered and new items of interest.

In the end, perhaps the most important issue was broached by Representative Davis.

“Please, contact us. An e-mail is OK, but those can get overlooked or may not make it through the junk mail filters. Your best bet is a written letter, or to call us. Remember, it’s meetings like this that help us know what issues need to be addressed.”

“And if you’re in Jeff City, most of us, myself included, practice an open door policy. Come and see us,” added Representative Flanigan.

As the other elected representatives at the table nodded in agreement, I couldn’t help but to back to the words of former Minnesota governor Jesse Ventura who once said, “Government is at its worst when you have apathy from its citizens,” implying an active group of citizens, regardless of which side of the isle they are on, only makes our nation stronger.







## **ELKS MOBILE DENTAL PROGRAM**

### **Patient Eligibility**

1. Children and adults who have developmental disabilities or intellectual disabilities (DD/ID) as identified by the Department of Mental Health, Division of Developmental Disabilities.
2. Individuals in extreme financial distress, who have found it impossible to receive dental care anywhere else, must be referred through an Exalted Ruler or the Benevolent Trust Chairman. These individuals should be given a letter of referral from the Lodge. (A limited number of appointments are available)

Notes: 1. Individuals, 1-2 above, must be screened for their eligibility and their ability to receive treatment in a mobile clinic with the aid of local anesthesia when indicated.

2. The Missouri Elks urge all eligible individuals currently under the care of a private dentist to continue treatment with him/her.
