

# Membership


The 2013-2014 Annual Membership and Charity Reports were to be filed at Elk.Org. As of April 1, 2014, the Order has 1,964 active Lodges. For the year, we suffered a loss of 2.8 percent or 23,288 Members, bringing our total membership to 802,592. The Annual Charity Reports have been filed and statistics show the Order provided more than \$330,000,000 in donations of time, mileage and in-kind gifts.

According to the totals used by the National foundation I calculated 29,664 members in Missouri which is also down.

# **Drug Awareness** ESSAY & POSTER CONTESTS 2014 – 2015

THEME – REFUSE TO USE...YOU'RE NEVER ALONE!!!

Essay – Grades 6-8, 500 words or less, handwritten or typed. Each entry must have name, age, school & name of Lodge sponsoring (on back is fine). A "Hold Harmless Waiver". NO **SS#** is required! Make copy before sending on to District & State as Essays become to property of B.P.O.E.

Poster – Grades 3-5, size is 8 ½" x 11", should contain an anti-drug message, **not** depict any copywrited character or trademarks, **EXCEPT** for **Elroy!** Need name, age, grade, home address, name of their school & name of sponsoring Lodge on Poster. A "Hold Harmless Waiver" and remember, Posters become property of B.P.O.E. so make copies before sending on to District and State.

Entries should be back to the **Lodges by Jan. 15, 2015,** In to the **District by Feb. 15, 2015,** And in to **State by March 01, 2015** Entries submitted at the Spring Convention **will not be judged!!!** 

Lodges and Districts can have as many "places" in the contests as they want, **HOWEVER**, there will be only **ONE WINNER IN THE ESSAY AND**ONE IN THE **POSTER CONTEST FORWARDED TO THE NEXT LEVEL!!!** 

The prizes at state level are; 1<sup>st</sup> - \$300, 2<sup>nd</sup> - \$200, 3<sup>rd</sup> - \$100 – this is for both the poster, and the essay contests **for a total of \$1,200 from our state!!!** 

A message from Charlie: Besides the Contest Schedules, the main thing in my report aside from statistics will be on lodges need to report, through their secretary, their charitable works into the CLMS system. This includes their Drug Awareness Program works. I understand that entries into the system can be made throughout the lodge year but unless the secretary enters or clicks on "final" before April 10th all information is gone and not "reported". Last year at this time 29 of 75 lodges had reported, and this year only 28!

Elks are very good at charity works, but do poorly reporting them. Accurate and consistent reporting are essential to our Drug Awareness Programs as it shows everyone, including the government, just where Elks stand on the issue of protecting our children from drug abuse as well as illegal drugs!

I think it's important to note that our State Budget committee has allowed a total of \$1,200.00 in cash prizes to our essay and poster contest winners. This is another example of our commitment to our children and our efforts to increase their awareness to the dangers of drug abuse......Charlie Charlie Smith, Chairman

orn June 13, 1946, in Lackawanna, New York, to Russel and Anne M. Williams Entered into Rest June 24' 2014, in Columbia, Missouri

Russ Williams joined the Columbia Elks lodge April 1, 1978. He became our Exalted Ruler in 1995. This was followed by offices at the state and national level, including Northeast District Vice President, NE District Director, Missouri Elks State President, and District Deputy Grand Exalted Ruler. He was a 3-time Elk of the Year and was also an Officer of the Year in our lodge. In addition to serving as the National Foundation chairperson for our lodge, Russ also compiled many reports for us and tracked the numbers needed to compete for 'All-American Lodge' status. His efforts resulted in our lodge attaining AA-Lodge status for an unparalleled eight consecutive years! He was very proud of this. Also, at the time of his passing, he was serving on SIX state committees.

Russ also organized the annual planning for the Memorial Day parade float and the Flag Day ceremony. On the occasion of a recent Memorial Day parade, he openly criticized the parade's planning committee when the parade was cancelled because of something as minor as a tornado watch. He knew that weather did not stop our deployed troops from their mission and was ready to "drive-on" to show support for their service. He was a driving force in promoting the Veteran of the Month program. Russ never met a veteran he did not thank for their service.

He attended all lodge meetings and was on top of all lodge happenings. Russ consistently endeavored to inspire us to do good for each other, our lodge and our community. # Jefferson County DDRB Approves Funding For Elks Mobile Dental Program


Since 2012, the Jefferson County Developmental Disabilities Resource Board has allowed the Elks Mobile Dental Program to present a proposal, every year, requesting funds. If approved, the funds may be used to reimburse the Mobile Unit for services provided to eligible Jefferson County patients.

The Elks Program, with the support of the St. Louis Regional Office, has been approved up to \$5,000.00 in additional funding again for the FY 2015. That makes \$15,000.00 since 2012. Jefferson County is the only one of 85 Missouri counties, with Senate Bill 40 Boards, that help provide access to the Mobile Dental Unit.

Jefferson County DDRB is a forerunner in Missouri recognizing that dental care is an important part of an overall health plan. They help provide a service greatly underfunded by the state for special needs patients.

The Elks Mobile Dental Program is always looking for additional sources of revenue. We appreciate the opportunity to continue in our mission. There is a great need for our services in every Missouri County. If you know any members of a County Board of Services for the Developmentally Disabled let them know what Jefferson County has done.
