In 2016-2017, the Elks National Foundation will distribute \$27.3 million to help Elks build stronger communities by investing \$9.8 million in Community Investment Program grants for Elks Lodges to invest directly in their local communities. The ENF will allocate \$9.1 million to help State Associations accomplish their charitable objectives.

The ENF will continue to further the education of our country's future leaders by allocating \$4.2 million in scholarship assistance. The ENF designated \$729,330 to fund Drug Awareness and \$952,760 to run the Elks National Hoop Shoot Free Throw Program, encouraging youth to lead healthy and active lives. In addition, the Elks National Foundation designated \$1.464 million to fund the Order's Veterans Service Program.

In order to continue funding these great programs, the Elks National Foundation needs our support. We must all support the ENF by donating and volunteering with ENF programs. The goal we have established for 2016-17 is \$4.65 per Member. This is not much when you consider the outstanding achievements of the ENF. I am hopeful that every Lodge will strive to meet or surpass this amount.





Cass County Lodge 2791 worked the crowd selling the PER "Kick-ass" mule pins bringing in \$2,945. I also want to thank Don and Susan Cook, Heather Coots and Doug Jordan for helping at the booth by assisting convention attendees with their questions about our major state program, selling pins and raffle tickets. Their help was greatly appreciated.

This year we held a raffle to raise funds for our Benevolent Trust - two suitcases full of Missouri made wines. I want to thank Sherri and Valerie who sold the majority of tickets. Along with all those who manned our booth \$1580 was raised. Thank you again to all who assisted at our booth and those who purchased tickets.

I am also proud to say we received a "5 Star" rating (5 being the highest) for content and appearance of our booth. After receiving a "3 Star" rating last year we put a little more "pizzazz" in this year's booth.

The new Benevolent Trust Dental Labs are nearing completion. Both units are at the Truman Medical Center and have been fully outfitted with dental equipment. At the time of this writing I am sending the finalized design for the vehicle wrap as per



agreement by the Missouri Benevolent Trust Board of Management. These new units will be our shining star showing our long-term commitment to help those in our communities. In the near future these two units will be traveling the roads of Missouri keeping patients and all of us smiling.

#### Resolutions Passed National Convention

2016-01 – To rename the Grand Lodge Public Relations Committee the Public Relations and Marketing Committee to better reflect the practices, duties and responsibilities of the Committee. Yes, 2346; no, 62. Passed

n 2016-02 – To eliminate any responsibility for the Elks National Home given its recent sale. Yes, 2378; No, 26. 98.92 percent. Constitutional amendment. Passage subject to Lodge ratification.

2016-03 – To allow a Lodge, by By-Law, to set the reinstatement fee at any amount it wants, or to eliminate it altogether. Yes, 2069; No, 316. Passed

2016-04 – To allow a Lodge, by By-Law, to set the initiation fee at any amount it wants, or to eliminate it altogether. Yes, 2052; No, 339. Passed

2016-07 – To provide that seven Members shall constitute a quorum in Local Lodges with membership of 99 or less. Yes, 2195; no, 195. 91.84 percent. Constitutional amendment. Passage subject to Lodge ratification.

2016-08 – To return to an incorporated Lodge the choice of having a Board of Trustees or a Board of Directors as the Managing Body of the Lodge. Yes, 1783; No, 611. Passed

2016-09 – To clarify that the number of elected Trustees of a Lodge shall be not less than three nor more than five. Yes, 2314; No, 89. 96.30 percent. Constitutional amendment. Passage subject to Lodge ratification

2016-10 – To clarify that a widow or widower of a deceased Member, who subsequently remarries, is not eligible for an identification card. Yes, 2041; No, 329. Passed n





St. Charles The Beginning
(Note: Some of this story, especially before the lodge started is a guess based on the times and assumptions from who be-came the first ER and charter officers.)

In 1900 A thirty-seven year old resident William F. Bloebaum had just been appointed Postmaster to the city a year earlier. Bloebaum was a well-educated man, who was well known for being a political person. Sure he was happy getting the appointment to Postmaster, after all his pay was about double the average at the time, but he was always looking to network and meet people for the future opportunities.

Through his new job as Postmaster Bloebaum It is more than likely, he was invited by another postmaster to visit the St. Louis Elks Lodge #9 for a cigar and a drink.. The St. Louis Lodge was the 9th lodge of the order, established in 1878. Here he saw a beautiful lodge. "Why don't we start one in St. Charles too?" Had to be the question either from or to Bloebaum." "You need to sign up 25 members to start and then your there". Bloebaum went back to St. Charles and told friends and of his experience at the St. Louis Elks and started getting a feel for how many were interested.

On Bloebaum's 2nd trip to the St. Louis Lodge, he brought a small group to visit from St. Charles. The group met at the train station by the river for the trip to St. Louis by train. .

After that trip Bloebaum had help and they had at least 25 signed up and by April 21st of 1901 they were all initiated in the Elks. The next week on April 27th the charter officers were installed at Odd Fellows Hall.







#### Assistance for Worthy, Needy

Members Needy Elks Members can qualify for up to \$1,000 in an emergency 50-50 matching grant from the Order under Statutes Section 5.070. The assistance would be available to "worthy and needy Members of the Order who are suffering from diseases of an incurable character or from total disability, and who are without funds or property or relatives able or willing to care for them," the Statute states. The Statute also provides that the Lodge of the assisted Member "shall contribute

toward the relief of the Member an amount not less than one-half of the sum that is contributed by the Order." The assistance program is administered by the Board of Grand Trustees, which is authorized to appropriate up to \$10,000 annually for the program. The board by resolution may give the Grand Exalted Ruler up to \$1,000 so that authorized payments may be made regularly by him. "The monies so appropriated shall be administered by the Grand Exalted Ruler with the consent of a majority of the Board of Grand Trustees," the Statute states.
