There are now informational videos for every GL Activities program located on Elks.org that any registered user may access. These are short movies that provide an overview of the programs we encourage all lodges to adopt and participate. I urge you to view them all and incorporate into your indoctrination program for new members. The

committee has also updated or created new brochures for all the Activities programs. They can be found on Elks.org as well and are downloadable/printable pamphlets that can be dispersed to your membership to explain what and how the programs work. Please review these programs, they are in place to let our communities know what Elks do to make our homes and firesides a better place to live.

I would prefer to detail each and every program available to our Show-Me State lodges, but space restraints prevent this. However, I will give an update on the program for which I've received the most calls, emails and questions. Scouting. Our Scouting Program is alive and well. At this time, the only difference in Scouting and the Elks is that your Lodge is NOT allowed to sign any new charters or sign any re-charters sponsoring Scouting Troops. Your lodge can still award Eagle certificates to Boy Scouts. You can still give Gold, Silver and Bronze certificates to deserving Girl Scouts. Scouts can still help with activities in your lodge. They can still hold box car derby's or assist with Flag Day or flag retirement ceremonies. Your lodge can still nominate deserving Elk members for the Marvin M. Lewis award. Until such time as current litigation is complete, and we are directed otherwise, please support all Scouts and our Scouting program. Just don't sign any charters. As always, please contact the MEA Youth or MEA Lodge Activities committee person for additional information or feel free to call me anytime.





Drug Awareness, Audit and Acct

It's always great to be back together at Convention, and I hope everyone had a good Summer.

There are still Lodges that have not uploaded their FY 2022 information to the Grand Lodge site. Please remember the due date was August 1, regardless of what your tax preparer tells you. An "extension" only applies to the IRS

due date, not to the Grand Lodge due date.

Submission is a 3-step process this year. An online transmittal letter must be completed, then a Lodge balance sheet uploaded, followed by an upload of the tax return. Remember that the Lodge balance sheet must be from your Lodge accounting software, not from the FRS.

Something often incorrectly reported is the information regarding the number of members on the Lodge governing body. Per the Grand Lodge Auditing & Accounting manual, the number reported on Form 990 Line 3 and Line 4 cannot exceed nine (9). This is the maximum number of Chair Officers and Trustees in a Lodge, and is considered the Lodge governing body. This number will increase to a maximum of eleven (11) for fiscal year ending 03/31/2023, with the inclusion of the Lodge Secretary and the Lodge Treasurer as approved by the majority at Grand Lodge in Atlanta.

The monthly FRS reports sent to you by your District Deputy should be compared to your Lodge financial statements. This gives the Lodge an opportunity to see potential "problems" prior to the fiscal year-end, and make the appropriate adjustments.

Membership has made a fantastic recovery from the effects of COVID-19 of 2021. Nationally our order added 97,643 new members with Missouri adding 3,637. Total gains were 25,000 for the nation and 982 for Missouri and a 7th place finish in the Nation. That's the good news. The not so good news is that our order lost 41,287 members for nonpayment of dues: Missouri 1.712. This is an area that Missouri and the Nation



needs to work harder on in this current year.

It was truly an honor to return to the front stage at the 2022 National Convention in Atlanta along with PSP John Rinehart to receive our plaque for Missouri's 7 th place finish. That is four out of the last 5 years and hope for another return to the front with another successful year from Missouri. We have become know as a leader in membership by the Grand Lodge, something for all of us to be proud of. We are the Show Me State and we continue to show them.

Top Lodges for membership gain this year by percentage of membership are: 1 st Place Ellisville #2664 with a 35% (50) gain, 2 nd Place Alton-Thayer #2545 with a 34.2% (25) gain and 3 rd Place is Christian County #2777 with a 31.2% (48) gain. Honorable Mention is Webb City #861 with a 25.1% (44) gain. The Lodge with the highest gross membership gain is St. Louis #9 with a gain of 105 members.


