



Leadership Training Missouri Elks Association Fall 2024

Since 2018, with the exception of the 2020 Covid year, we have gained in the number of people who have attended the Officer Training. In 2018 we had 97 participants and 24 Lodges represented. In 2019 we jumped to 118 participants with 30 Lodges represented. Then we took a covid break in 2020 but we rebounded nicely in 2021 with 129 participants. In 2022 we had 147 participants with 36 lodges represented. That's more than half the Lodges in Missouri. In 2023 we had a good year with 185 participants and 40 Lodges represented. This



year the number of participants jumped all the way to 210 with 42 Lodges repre-

sented. Thank you, thank you, thank you!

I wish to Sincerely thank Florissant Lodge #2316 and Blue Springs Lodge #2509 for their accommodations and their hospitality. Blue Springs Lodge hosted our Officer Training session then later that evening celebrated their Fiftieth Anniversary.

The success of the Officer Training program is a direct result of the willingness of Lodges to open their facilities to other Members throughout the State and because of the Officers who truly want to lead their Lodges in the right manner. Every time we ask, we have Lodges willing to step up. This is a true testament to what we are as an organization and to who we are as Elks.

We are currently seeking Lodges willing to host the Officer Training in the Spring of 2025. It is the desire of the committee to conduct sessions early in the year to bring the most value to new Officers and members who are interested in attending. We try to hold either a single, centrally-located session or two sessions when we can identify Lodges with a willingness to host. Although we do want to ensure we have a broad membership base that wouldn't have to travel too far to attend.

The one thing about our sessions is there is always active participation and many members come with good questions and a desire to learn. This is also a perfect opportunity for Exalted Rulers to put together a team building event and get away from your home lodge.

We are doing our best to try to improve the Officer Training experience. This year we were able to stay within our budget and purchase a projector and screen that we hope will improve the sessions.




Auditing and Accounting

Hello and welcome back to Jefferson City!

It is an honor to serve another year on the Grand Lodge Auditing & Accounting committee, and I thank PGER Lou Sulsberger and SD/Grand Trustee John Gross for the opportunity to continue serving our Order.

I commend the District Deputies this year for becoming involved and literally hitting



When you receive the FRS reports from your District Deputy, please remember to forward them to the responsible parties in your Lodge (e.g., Lodge Secretary, Lodge Treasurer). Be sure to include your Lodge Auditing & Accounting committee. If the District Deputy tells you nothing was submitted for a particular month, please do not argue with them. In this respect, the numbers do not lie. Please be aware that Adaptive always sends an email verifying receipt of the FRS file. That email does not guarantee that the file was accepted at Adaptive. Nonacceptance of a file is often caused by incorrect or missing account numbers. If your file is not appearing in the FRS, please contact Patrick Weber at Grand Lodge. (PatrickW@elks.org) Patrick can look "behind the scenes" and potentially determine why the file errored out.

When your Lodge needs to add an account number, please reference the Grand Lodge Chart of Accounts (Chapter 4, Grand Lodge Auditing & Accounting manual). The Chart of Accounts will tell you the classification of an account and you should use this same classification in Quickbooks. For example, a Lodge recently used account 28000 "Deferred Income" and classified the account in Quickbooks as "Other Current Asset". While the account appeared in the Asset section of their Lodge Balance Sheet, the FRS balance sheet properly classified the account as a Long-Term Liability. If the Lodge had been reviewing their FRS reports monthly, this problem might have been corrected prior to the end of the year.

Additionally, if your Lodge accountant and/or tax preparer can make entries into your Quickbooks account, please make sure they have a copy of the current Grand Lodge Chart of Accounts. This can prevent future problems if they need to add accounts.


A prompt review and response to questions from your District Deputy (or myself) can also preclude having to deal with problems at year -end. Certainly, if you do not understand an email or question, please reach out to someone—either your District Deputy or me.

Lastly, at the Grand Lodge session in Austin, the Grand Lodge Auditing & Accounting committee made the recommendation to allow Lodges not in compliance with FRS to use the Lodge balance sheet balances as of 3/31/2023 as new "beginning" balances in FRS, providing certain conditions are met. Knowing this, please do not upload new balances to the FRS until you hear from me. Certain steps must be taken before new balances can be uploaded, otherwise your FRS balance sheet will be overstated. I will contact your Lodge if you meet the criteria, with detailed instructions for the upload.

The Real History of Elroy the Elk

Elroy The Elk began as an idea from Gary Hamby. Gary is a member of the Festus-Crystal City elks #1721 and felt that there should be something to appeal to children that would help with drug awareness and alcohol abuse.

Gary was the drug awareness chairman for the Missouri Elks ssociation and he believed that possibly a cartoon character would peak their interest!

He began drawing different characters and eventually came up with the concept of Elroy Elk. This elk was larger than life who had a huge pair of glasses, a pair of trousers with suspenders, a bow tie and a bright yellow shirt.

He thought that his drawing was just that, a drawing. He believed that it would go no further. But two of his friends, Lee Womack and Larry Johnson felt differently.

They took the drawings to the Kincaid Karacter company and had them develop a complete Elroy Elk Mascot costume that could be worn to demonstrate something that children and adults alike would relate to.

Once the costume was made, Larry Johnson wore it to a lodge meeting in 1987 and surprised Gary

with the real life Elroy Elk.
