



2025–2026 Missouri Elks Association State President Jason Meisenheimer



I cannot believe it is already Spring 2025 and that I have the honor of serving as MEA State President for the next year! Trust me when I say that life has been a roller coaster of nerves since that election a year and a half ago!

But I digress. It is time to quit thinking about the past and plan for the future. In this article, I want to share some of my goals for the next 12 months.

My initial focus will be on Veterans Awareness issues. I know that all of our great Lodges have amazing Veterans Programs. And our committees work hard to ensure that Veterans needs are met in a wide variety of ways.

Unfortunately, there is one program that I feel must be highlighted—Veteran Suicide Awareness. It is a staggering fact that there were an average 131.2 suicides per day among U.S. adults in 2022, including 17.6 per day among Veterans and 113.7 per day among non-Veteran adults. Friends, that is way too many. So I am requesting each Lodge do one more program to support your area Veterans. It does not have to be grand in scale, just do something to support our Veterans. It can be something as simple as hosting a dinner for area veterans, visiting veterans in area nursing homes, or simply providing them with home cleaning supplies. You never know when that one thing you do will save the life of a Veteran or non-Veteran. If you have any questions about what you can do, please reach out to Darrel Quinley, MEA Veterans Services Chairman; he has some great ideas!

I apologize for hitting hard with the first punch, so I will take it a little easier going forward. Membership is a constant battle for most Elks Lodges. I want to build on the foundation that Jim Ross, MEA State President 2024-25, and Matt Wideman, MEA Membership Chairman, have worked hard to construct. Missouri has consistently ranked in the Top 10 for many years, and I know we can keep up that pace.

I believe a major factor in our growth is lowering our delinquency/lapsation rates. We cannot keep fighting out of a deficit to see a positive gain. How do we do that? We need to actively engage our New Initiates and that starts with reviewing our Indoctrination Procedures. I have challenged Matt to do some research as to what can possibly be done to improve in that area. There are obviously some Lodges that are succeeding while others are struggling. We do not need to reinvent the wheel. We can capitalize on successful practices and share that information.

Another way to improve our Membership is to toot our own horns a little bit more. We are guilty of hiding the lamp of Elkdom under bushel baskets, instead of letting it blaze forth for all to see. Jeremiah Cook, MEA Public Relations Chairman, will be reaching out to our Lodges with plans on just how to do that. His information will cover how to connect with news media in your area. He will also focus on ways to recognize those Lodge Members and our community volunteers for the work that they do in service to others. We hope to make this as seamless as possible for maximum effect.

In closing, I thank each of you who work tirelessly to see our Lodges grow. None of us would be where we are without the selfless acts that each of you do on a regular basis to help others in need. I look forward to visiting each Lodge to see the great things that you do. Never forget, **Thank a Vet. Elks Care, Save a Pair. Elks Heed the Cry of Affliction.**

Veterans



It's been an exceptional year for veteran's programs. The ENVSC., Elks National Veterans Service Commissions annual report speaks to the success of the Welcome Home Kits and Freedom Grants. There have been 3,412 kits distributed which is a 41% increase from last year. As you know these are from \$400.00 to \$600.00 reimbursable to your lodge. There were 595 Freedom Grants approved that served 86,673 veterans with over 9,000 Elks involved.

Nationwide we have 670 Elk VAVSs and Deputy VAVSs in over 390 facilities serving 480,000 veterans. The ENVSC appropriated over 5 million dollars.

In Missouri we have 18 VA facilities that are served by Elk VAVSs and Deputy VA(VSs. We also have 25 CBOCs, Community Based Outpatient Clinics throughout the state.

Your Districts and lodges continue to serve veteran's and their families at the grass root level. That's what we do best. We offer veteran's a hand up, not a hand out. When called on, we ensure a veteran coming out of homelessness has new clothes, dignity products, a safe place to lay his or her head at night, and food for the next day and weeks to come. Fellow Elks, we make a difference. Once this former homeless veteran starts feeling better about himself personal progress follows shortly after.

Thank you brothers and sisters, you are the Elks that do the work, and it's alright to stand up and take a bow.


Proceeds from the Fall Boutique will be divided equally between the Missouri Benevolent Trust Fund and the Elks National Foundation.


I invite each Lodge to donate an item or two for this event, which will include silent and live auctions, as well as raffle items.



Auditing and Accounting



Hello friends, and welcome to the 2025 MEA Spring Convention. Spring Convention brings together friends and "family" that see each other twice a year and also brings the reminder that the end of the Lodge year is almost upon us.

The end-of-year submission requirements to elks.org are unchanged. The online "Transmittal Letter" must be completed, followed by the upload to elks.org of the Lodge balance sheet (from Quickbooks, Sage, etc.) and complete Form 990, 990-EZ or 990-N. These actions are required to be completed no later than August 1. Please remember that the uploaded Lodge balance sheet should reconcile to the 990 or 990-EZ. Simply stated, the Lodge balance sheet uploaded to elks.org should include any adjusting journal entries recommended by your tax preparer (e.g., depreciation, inventory change, etc.), and the total assets reported on the balance sheet should be the same as the reported total assets on the tax return.

Please remember that you should not be reporting zero or no volunteers on line 6 of Form 990. It is difficult to substantiate your status as a charitable organization if you do not have any volunteers. At a minimum, your uncompensated Lodge officers and committee chairpersons are considered volunteers.

This time last year, Missouri was at 13% compliance with the FRS. Currently (the second week of February), we are at 73% compliance. This means that 52 of our 71 Lodges have FRS balance sheets that reconciled to their Lodge balance sheet (and the 990) as of 3/31/2024. The increased compliance is representative of the dedication and perseverance of many individuals, and I thank them for their assistance in this endeavor. 




